

CHEROKEE NATION TAX COMMISSION ABANDONED VEHICLE INSTRUCTIONS TO TAXPAYER

Outline of procedure when a vehicle is to be sold to satisfy a mechanic's lien pursuant to the provisions of Section 204 of LA 01-01, 7-06.

Property must be in the seller's possession at least thirty (30) days prior to starting the Abandoned Vehicle sale process.

Notice to storage lien filers:All property stored, parked or left in garage or other storage facility
must be reported to CNTC after 30 days.

OWNERSHIP DETERMINATION

Record ownership and the existence of any lien holders must be determined in order that they may be notified of the impending sale.

- If the property has a Cherokee Nation tag/registration number, contact the Cherokee Nation Tax Commission Motor Vehicle Division for ownership/lien holder information.
- If the property has an Oklahoma tag/registration, contact the Oklahoma Tax Commission Motor Vehicle Division for ownership/lien holder information.
- If the property is from another state or tribe contact the Motor Vehicle Division for that state or for ownership/lien holder information.
- Letters from other states MVD providing that information are acceptable. (Teletype printouts from law enforcement agencies are not acceptable).

NOTICE OF SALE (FORM 18-01)

The **Notice of Sale** must be completed in its entirety, list all parties (who are each to be notified by certified mail), a complete vehicle description, storage / possession date, services rendered, total amount due, and time / date / location of the sale. The sale may not be held less than ten (10) days following the mailing of the Notices. Refer to the following example of determining the earliest sale date.

Date Notices Mailed	January 1
Day 1	January 2
Day 10	January 11
Earliest Sale Date	January 12

A copy of the **Notice of Sale** must be posted in three public places within the county in which the property is to be sold. A copy of the **Notice of Sale** must also be mailed by certified mail, with a return receipt requested, to each interested party as outlined below:

- Party who brought property to you.
- Record owner as reflected in the files of Motor Vehicle of the Cherokee Nation Tax Commission, or files of the state where property is registered.
- Any assigned owner, as reflected in the files of the Cherokee Nation Tax Commission.
- All lien holders and lien debtors of record.

The white certified mail receipt must have the name and address indicating where the Notice of Sale was sent. It must be postmarked by the post office. This postmark date will be used to establish the date mailed in verifying the required ten-day period elapsed between the mailing date and the property sale date.

PROOF OF POSTING AND MAILING (FORM CN 19-01)

The **Proof of Posting and Mailing** is to be completed in its entirety, listing a complete vehicle description, the location where the Notice of Sale was posted and all interested parties that were notified by certified mail.

RETURN OF SALE (ASSIGNMENT OF OWNERSHIP) FORM CN 20-01)

The **Return of Sale** is to be completed upon sale of the property, recording the date of sale, purchase price, the new owner (buyer), and the odometer disclosure information. (Note: Odometer disclosure is required on Year "2010" & newer).

FOLLOWING THE PUBLIC SALE OF THE PROPERTY

Following the sale of the property, the following **properly completed and notarized original documents (photocopies are unacceptable)** must be submitted to the Cherokee Nation Tax Commission Motor Vehicle Division:

- 1. Notice of Sale (Form 18-01)
- 2. Proof of Post and Mailing (Form 19-01)
- 3. White postmarked certified mailing receipt(s)
- 4. Return of Sale (Form 20-01)
- 5. Printout(s) of the vehicle record from the applicable Motor Vehicle Division
- 6. Copy of Cherokee Nation Citizenship Card

Note: Seller / DBA, where required on forms, is the person / company filing. To avoid penalties, all documents must be submitted within thirty (30) days following the sale.

Following review of the documents by Motor Vehicle Division, the paperwork will be returned to the person / company conducting the sale with either approval instructions, or a denial and explanation.

SUBMISSION OF THE COMPLETED PAPERWORK TO THE CHEROKEE NATION TAX COMMISSION DOES NOT GUARANTEE APPROVAL OF OWNERSHIP TRANSFER.

VEHICLES ACQUIRED THROUGH THE PROCESS MAY BE SUBJECT TO ALL DELIQUENT FEES AND TAXES DUE TO THE CHEROKEE NATION TAX COMMISSION.
