# LICENSE PLATE APPLICANT MUST ATTACH CONFIRMATION LETTER FROM THE OKLAHOMA DEPARTMENT OF VETERAN AFFAIRS.

#### The Ex POW's name must appear on the face of the title and have a Cherokee Citizenship card.

Plates designed for honorable discharged or present members of the United States Armed Forces and civilians who are former prisoners of war held by a foreign country and who can provide proper certification of that status.

## CHEROKEE NATION TAX COMMISSION EX PRISONER OF WAR LICENSE PLATE APPLICATION

- 1. This special plate registration is in addition to, not in lieu of, your regular registration (i.e. standard license plate). Your regular registration must be kept current at all times. Failure to renew the regular registration in a timely manner may result in a delinquent registration penalty and/or possible law enforcement citation.
- 2. Once a special license plate has been assigned to an applicant, the applicant shall have priority to such license plate for succeeding years, provided a timely paid application for renewal is submitted. To insure that you receive a renewal application each year, please notify Cherokee Nation Tax Commission of any change in your address.
- 3. A special license plate is to be displayed on the rear of the vehicle for which it is issued. The regular license plate may be kept inside the vehicle and produced upon request by law enforcement.
- 4. A special license plate may be transferred to another vehicle upon the owner's submission of a completed <u>46-01 Request to Transfer</u> Form to the Motor Vehicle Division. This form may be obtained from any Cherokee Nation Tag Office or through the Cherokee Nation Tax Commission website <u>www.cherokee.org</u>
- 5. Your Special License Plate will be mailed to the address listed in the Motor Vehicle Tag Database and can be updated upon the owner's submission of a completed <u>56-01 Address Change Form</u> to the Motor Vehicle Division. This form may be obtained from any Cherokee Nation Tag Office or through the Cherokee Nation Tax Commission website <u>www.cherokee.org</u>
